All tables, chairs, tents, etc. must be provided by the exhibitor. Tents and canopies can be used; no larger than 10'x 10'. Please let us know if you will be using the following by placing a check on the application: Tent, Trailer, Grill or Generator.

- No cans of string, stink bombs or poppers.**
- NO WEAPON SALES**
- No Flea Market/ Yard Sale items**

All booths must be set-up and All vehicles must be removed from festival area by 7:45am. Booths must be ready for business at 9:00am and must remain open until 5:00pm (rain or shine). Remove all garbage / trash!

VENDOR RULES & GUIDELINES

1. Applications must be postmarked by application deadline – September 12, 2011. No applications will be accepted after this date.
2. No refunds, no exceptions. Fees paid may not be applied to a future event.
3. The Festival Committee reserves the right to limit the number of similar type vendors.
4. All vendors are responsible for their own liability insurance and must provide a certificate upon request of the Festival Committee.
5. All vendors should not exceed the boundaries of their assigned spaces which are 10' x 10' each. Vendors needing additional space will be expected to reserve two (or more) spaces as needed. Canopies and tents **MUST** be totally contained within the assigned space. Staking of tents is prohibited. **Vendors using trailers need to measure their length from the furthest point on each end, including the trailer hitch.**
6. All vendors are responsible for clean up and trash removal from their spaces. A \$50 fine will be issued by the Harlem Department of Public Safety for any debris left in your space.
7. All vendors must have vehicles unloaded into their space and vehicles removed from the Festival area by 7:45am. Booths must be ready for business at 9:00am and must remain open until 5:00pm.
8. Electricity and water is not available to vendors.
9. Parking or driving on sidewalks is prohibited. Violators will be fined by Harlem Dept. of Public Safety.

ADDITIONAL RULES & GUIDELINES FOR FOOD VENDORS

10. If using a trailer, food vendors must purchase a minimum of 2 spaces. **NO TRAILERS WILL FIT INTO ONLY ONE 10' X 10' SPACE.**
11. All food vendors must provide a complete list of food items and beverages for sale. Vendors agree to sell only those items listed on the original application.
12. The Festival Committee reserves the right to place food vendors on the Festival grounds according to a master plan. This may include designated areas for food vendors.
13. All food vendors are **REQUIRED** to place a protective layer, such as plywood, underneath any grills, cookers, deep fryers, etc.
14. All food vendors are **REQUIRED** to pay a \$50.00 deposit, refundable within two weeks of the festival, providing the spaces rented are cleaned and spot free.

*****ATTENTION ALL VENDORS*****

IF USING A GENERATOR, THE NOISE LIMIT MAY NOT EXCEED 60 DB AT 50' FROM THE SOURCE.
